## STICKNEY TOWNSHIP YOUTH COMMISSION

### PRE K 3

This program is for children who will be **3 years of age by September 1, 2019**. There are four eight week sessions throughout the school year and the cost for each session is \$40.00. Classes meet on Tuesdays and Thursdays.

### PRE K 4

Children must be **4 years of age by September 1, 2019** to participate in this program. There are four eight week sessions throughout the school year and cost for each session is \$60.00. Classes meet on Mondays, Wednesdays and Fridays.

Both programs are designed to meet the needs of children in their age group. Weekly themes are centered around the alphabet, numbers, colors and shapes. These programs encourage expression through crafts, music and dramatic play and also promotes the development and enhancement of age-appropriate social skills.

<b>SESSION 3:</b> January 21 - March 13, 2020	<b>SESSION 4:</b> March 16 - May 15, 2020

Children must be **toilet trained**. Only the parent or legal guardian may register participants. (Legal guardian must provide court papers). **Three proofs of residency including a current Illinois Driver's License or Illinois State ID card are required as well as a valid Stickney Township ID for the parent that is registering child.** (This card can be obtained from any of the three Stickney Township medical buildings for free). In addition, two of the following must be provided at the time of registration: Current utility bills, property tax bill (or lease), auto registration, or auto insurance card. **Child's certified birth certificate and immunization record are also required at time of registration. Full payment is due at time of registration (cash or check only is accepted).** For those families who present a valid HFS issued medical card showing the parent (not just the child) as the insured will pay half the price for the Pre K programs.



**No refunds will be granted after August 16, 2019**



### **PROGRAM REGISTRATION POLICY**

- Registration for Pre K programs and Summer Fun will be offered to the families of students currently enrolled in the Youth Commission's Pre K program April 15-26, 2019. (Registration packets will be distributed by Youth Commission staff two weeks prior).
- Public registration for remaining available slots will begin at 8:30 am on Monday, May 20, 2019 by reserving a spot for your child online at [townshipofstickney.org](http://townshipofstickney.org) (under Youth Commission and Burbank/Louis S. Viverito Senior Center location). Reservations are based on "first come first served basis" and each reservation will be time stamped and opportunities to register will be based on time of submission. Depending on prior registrations to the program there will be varying openings for program reservations. Once all slots are reserved the remaining reservations will be placed on a waiting list.
- Registration forms will be available for download from [townshipofstickney.org](http://townshipofstickney.org).
- Reserving a spot online is not a guarantee of registration. Pre K staff will notify those on the reserved list and provide each family with an appointment time to register their child/children at the preschool location. Required documentation, completed enrollment packet and payment complete the registration process. Those who do not show up for their scheduled appointment will forfeit their reservation and the next name on the wait list will be called. **All registrations must be done in person; the only online process is program reservation.**

### SUMMER PROGRAM REGISTRATION INFORMATION

Programs are for Stickney Township residents only. Parent or legal guardian must register child. (Legal guardian must show court papers). Three proofs of residency including a current Illinois Driver's License or Illinois State ID card are required as well as a valid Stickney Township ID for the parent registering child. (This card can be obtained from any of the three Stickney Township medical buildings for free). In addition, two of the following must be provided: Current utility bills, property tax bill (or lease), auto registration, or auto insurance card.

**Payment in full**, cash or check (made payable to Stickney Township)  
is required at time of registration.

**Cancellations for these programs must be made prior to  
Monday, June 3, 2019 in order for a refund to be granted.**
